

2024-2025 School Year TUITION RATES AND RELATED FEES

TUITION

Tuition is based on the academic year. For the convenience of payment, tuition is divided into (10) equal installments.

- The first scheduled payment is due July 5th, 2024. Tuition payments are due on the 5th of each month and those payments will be made July 2024 through January 2025 and March through May 2025. For the convenience of our families, the month of February has been set aside solely for the payment of registration fees/other fees for the following, 2025-2026 school year.
- Payments will be made via FACTS Tuition Management Services using a credit card/bank draft.

The following is the Tuition and Fee schedule for one student for the current 2024-2025 School Year:

FEES

- <u>REGISTRATION FEES</u>: Online registration for <u>current families</u> is due on or before January 12th, 2024. The standard, non-refundable registration fee of \$950 per student is payable on February 5th, 2024 and billed through FACTS Management for our <u>current families</u> only. <u>Current families</u> who register <u>AFTER</u> January 12th, 2024 will be assessed a non-refundable \$1,100 registration fee (\$950 standard registration fee + \$150 late fee).
 New families will submit payment of Registration Fee(s) at the time of acceptance to our school
 - <u>New families</u> will submit payment of Registration Fee(s) at the time of acceptance to our school. Registration fees are non-refundable and secure your child's place for the upcoming school year.
- NEW STUDENT/NEW SIBLING SCREENING FEE: \$50.00 per child (only applies to new students to our school, including siblings, in grades PK3 through eighth). This fee must be paid *prior to* your child(ren)'s screening appointment and is non-refundable. Incoming PK2 students do not require screening and, thus, will not incur a screening fee. However, if it is determined by Administration that a screener is recommended for an incoming PK2 student, the parents will be advised accordingly.

- <u>CRUSADER FUND (for New Families Only)</u>: New families to Saint Louis Covenant School will be expected to pledge a donation amount to the Covenant School's annual fund initiative. More details will be made available through the Development Office.
- CRUSADER FUND (for Returning Families Only): Current families of Saint Louis Covenant School will be expected to pledge a donation amount to the Covenant School's annual fund initiative. Should you have any questions, please contact the Development Director.

AGREEMENT CONFIRMATION NOTICE (for Returning Families Only)

FACTS Management will send an **Agreement Confirmation Notification** via email to all families of children confirmed to be returning to St. Louis Covenant School in August 2024. **It is very important that you carefully review this information.** This notification will show your schedule of payments for the upcoming school year (your payment schedule will only change from the prior year if you call the FACTS Account Manager, Sandy Fitl, directly at 866-441-4637 and advise of your desire to change your payment plan. Address changes and/or updates to payment accounts on file are to be made by parents via their FACTS account. Our school is unable to make any such changes. As a reminder, the registration payment will be due February 5th, 2024 and the first tuition payment will be due on July 5th, 2024.

FACTS NOTICE (for New Families Only)

Once the school has received the completed registration documents and enrollment is deemed finalized, new families will receive an email invite, with a link to establish your account with FACTS Management. FACTS is the online tuition management service that the school employs for the collection of fees and tuition via credit card or bank draft. Tuition payments are <u>not</u> accepted in the school office.
